## 1 Course Details

### 1.1 Calendar Description

This course examines the nature of disease in plants, including their causal agents, etiology, biology, epidemiology, and management. Emphasis is placed on the historical and social importance of plant diseases, and on current issues in plant health. Each student is required to make a collection of 20 plant disease specimens. Students must contact the course instructor before starting their collection.

### 1.2 Course Description

ENVS\*3210 Plant Pathology F (2-3) [0.5]. This course examines the nature of disease in plants. Emphasis is placed on the broad concepts and principles of plant pathology, pathogen biology, the historical and social importance of plant diseases, contemporary topics related to plant-pathogen interactions and plant disease management.

This course examines the nature of diseases in plants. Lectures deal primarily with broad concepts and principles of plant pathology, pathogen biology and diversity, contemporary topics related to plant-pathogen interactions and plant disease management. The laboratories involve the diagnosis of a variety of diseases; identification of plant pathogens; and preparation of disease reports and a plant disease collection. In addition to specifically addressing the University Learning Objectives of literacy, numeracy, depth and breadth of understanding, and love of learning, students will be expected to achieve the following learning objectives.

1. describe and recognize the principles of plant pathology and etiology of representative diseases and pathogens
  2. identify the historical and socio-economic importance of plant diseases by describing the extent of damage associated with major diseases

  4. describe the principles of disease management

### 6.2 Assessment Details

**Midterm Exam 1 (25%)**

**Date:** October 19 during lecture period

**Learning Outcome:** 1, 2, 4

Midterm Exam 1 is worth 25% of your final mark. It will take place during the regular 50 minute lecture period. The Midterm will examine you on all materials covered up to and including the lecture presented October 14. No aids (e.g., calculators, smart phones, notes) are permitted. The Midterm Exam will not be returned, however it may be reviewed and discussed by appointment with the instructor.

**Midterm Exam 2 (25%)**

**Date:** November 25, during lecture period

**Learning Outcome:** 1, 2, 4

Midterm exam 2 is worth 25% of your final mark. It will take place during the regular 50 minute lecture period. This Midterm is not cumulative and will examine you on all material covered after Midterm 1 up to and including the November 23 lecture. No aids (e.g., calculators, smart phones, notes) are permitted. The Midterm Exam will not be returned, however it may be reviewed and discussed by appointment with the instructor.

**Lab Quizzes (18%)**

**Date:** Mondays: September 26; October 17, 24, 31; November 7, 14, 21, in the regular lab room.

**Learning Outcome:** 1, 3, 4

There will be a total of seven quizzes at the start of select labs. All quizzes require integration of the materials presented in lectures and in laboratories. Each quiz will be based on the material covered in the previous 1-2 labs. If you write all seven quizzes, your lowest mark will be dropped.

**Plant Disease Reports (12%)**

**Date:** October 13; November 10

**Learning Outcome:** 1, 2, 3, 4

Each student has the opportunity to prepare two plant disease reports. The reports are valued at 6% each and are due by 10 pm ET on the due date in the CourseLink Dropbox. Assignments handed-in late to the Dropbox, for which an extension has not been granted ahead of time, will incur a penalty of 10% of the total marks available for the assignment per day, and will no longer be accepted five days after the due date (i.e., after 10 pm ET Tuesday October 18 for report 1 and 10 pm ET Tuesday November 15 for report 2), resulting in a mark of zero for the assignment.

**Plant Disease Collection (20%)**

**Date:** December 1

**Learning Outcome:** 1, 2, 3, 4

Each student has the opportunity to prepare a collection of 10 plant diseases. Some time is available during the weekly laboratory periods for identifying specimens for your collection, and there will be a lab that is primarily devoted to completing the disease collection. The plant disease collection is valued at 20% of your final mark and is due on December 1 in the regular lecture room at the beginning of the regular lecture period (1:30 pm ET). You may also hand in your collection during any lab period prior to this date. The due date for the disease collection is final, however an exception may be granted under exceptional cases. You must contact an instructor prior to the due date (December 1) to request an extension and discuss any accommodation

**Bonus presentation (optional) (0%)**

**Date:** Scheduled with the instructor

You can obtain up to four bonus marks added to your final course mark by delivering a presentation during a class or lab period on a recent topic that is related to plant pathology. The presentation can be completed by yourself or with one other classmate, with paired students receiving the same mark. If you do not deliver a presentation, you will have the opportunity to receive 2 (two) marks for evaluating the presentations. Further details are described under the Assessments tab in CourseLink. Please note that you can not receive a final grade above 100% in the course.
